

### COMMERCIAL 1 ZONE (C1Z)


### SCHEDULE TO THE COMMERCIAL 1 ZONE (C1Z)




#### DEVELOPMENT CONTRIBUTIONS PLAN OVERLAY - SCHEDULE 1 (DCPO1)

#### HERITAGE OVERLAY - SCHEDULE (HO335)







## Designated Bushfire Prone Areas
